 have fifteen flex time, no longer can shift trade one hour prior to shift, and they now must park and take bus to the
 airport. Some have returned to Reservations because of these differences
- Area Rep and Shop Stewarts have the right to challenge others doing our work. We filed grievances concerning Bags Inc.
- Three Schedule Bids per year.
- We are the Union and then there is the national. We all pay Union Dues.
- MOD retirement & Promotions Brian Chow is replacing Hunter at the TC. Josey is on the ramp. Serge is on B. 6 new managers coming into CLT
- Gate manning and staffing and how they are scheduling agents
- CSA & staffing equally assigning tasks.
- Management is assigning CARS to que the lines at the special services counter during IROPS. They will not tag bags. Article 4 of the Collective Bargaining Agreement
- Going to digital OT system. Starting 07/04/22. The system is not working, Angie had to call staffing to verify, because it is not showing up in WorkBrain immediately. Mandatory OT does not accept 0001 and it is showing unauthorized. Exception form is no longer an option
- Light/Limited Duty is back. President requested that management assign light duty agents as break relief. No crutches, no canes, no wheelchairs. It is up to management to implement the rules.
- Mandatory OT managers are not being consistent about how its implemented and how agents are being release
- Gates C5 & B15 are closed for construction and will be used as Special Services Counters during IROPS.
- Brittany is over FIS. FDC qualifications are necessary to work in FIS. Brittany or Jay can assist CSA's with getting the necessary qualifications
- The company is detaching the jetways from the ac for safety reasons
